Contributions to Truck PAC are not tax deductible for federal income purposes. Contributions to Truck PAC are for political purposes. All contributions to Truck PAC are voluntary. You may refuse to contribute without reprisal. The proposed contribution amounts are merely suggestions, you may choose to contribute more or less or not at all. ATA will not favor or disadvantage anyone by reason of the amount contributed or the decision whether to contribute. Federal law requires political committees to report the name, address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year.

No purchase, payment, or financial contribution is necessary to enter or win. A purchase, payment, or financial contribution does not increase the chances of winning. Do not participate if you do not reside in the United States or if you reside in the states of Texas, Georgia, or Minnesota. Void where prohibited or restricted by law. Federal law requires political committees to report the name, address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year.
