CONFIRMATION EMAIL:

Allow 3-4 business days to process all fax and email requests. Once your registration is successfully processed, you will receive an email confirmation containing the hotel booking link.

PAYMENT:

Registration forms will not be processed without payment and all credit card information fields are required. If you do not wish to register online or provide credit card information on the registration form you may register by mail. To avoid a balance due, do not submit payment until you verify your MSC/ATA membership status by emailing msc@trucking.org, atamembership@trucking.org and/or first-time discount eligibility by emailing registrations@trucking.org. The confirmation email with the hotel booking link will not send for meeting registrations with a balance due.

HOTEL INFORMATION
